**Time:** 9:00 am - Shotgun start on the Lake View Course

**Format:** Four-person Scramble

**Fee:** **\$175.00** per golfer for GAMA, AAMA, and affiliate members (affiliates = MAMA, TAMA, SCAC, KSEUSCC, and SAWF) and **\$200.00** for non-members. Teams from affiliate members are encouraged to enter and participate at the GAMA and AAMA member rate (save \$25.00). Fee includes Greens Fee, Golf Cart, Open Driving Range, Box Lunch, Beverage Tickets, Tournament Awards, and Gift Bags.

**Hospitality Hour:** Following the tournament. Awards will be presented at this time, as well as a Special Drawing.

**Awards:** Lowest Team Score, Runner-up Team Score, Closest to the Pin, and Longest Drive.

**Other:** Mulligans (up to two each player) can be purchased the morning of the event.

**Note:** A portion of the proceeds from the tournament will go to support scholarships given out by SAWF (Southern Automotive Women's Forum - a 501(c)(3) non-profit organization). SAWF's focus is on providing scholarship opportunities to young women pursuing an education in automotive-related fields of study. Last year, SAWF provided scholarships totaling over \$40,000 to young women in the southern region of the U.S.
